Know all men by these presents that Geo. L. Colburn and his wife Jennie L. Colburn, E. S. Fulch and his wife Annie Fulch, W. M. Hackney and his wife Ruth Hackney, and H. G. Forester and his wife Freda Forester, owners, have caused the land embraced in this plat to be surveyed, laid out and platted to be known as DE SOTO PARK and that all streets and alleys are hereby dedicated to the public.

A SUBDIVISION of certain land lying and being in Lake City, Columbia County, Florida, and more particularly described as follows.

Commencing at the inter-section of the east line of Hernando Street with the south line of Hillsboro Street and running thence east along the said south line of Hillsboro Street to the west line of Davis Street, thence south along the said west line of Davis Street to the north line of Circle Street, thence in a westerly direction along the said north line of Circle Street to the inter-section of said line with the north line of Hamilton Street, thence west along the said north line of Hamilton Street to a point 155 feet east of the east line of Hernando Street, thence north 30 feet, thence west 155 feet to a point on the east line of Hernando Street 30 feet north of the north line of Hamilton Street, thence north to the place of beginning.

I hereby certify that I am a registered engineer and that I made the survey and plat hereon shown and that this plat is a correct representation of the land platted, that permanent reference monuments have been placed as required by law and that all lots have been marked in accordance with the above plat.
