COMMENCE at the Southwest corner of SE 1/4 of NE 1/4 Section 27, Township 3 South, Range 16 East, Columbia County, Florida and run S 89° 48' 30" E along the South line of said SE 1/4 of NE 1/4 a distance of 251.73 feet to the POINT OF BEGINNING; thence N 5° 00' 56" W 56.89 feet; thence N 12° 40' 46" E 328.00 feet; thence N 75° 00' 17" E 173.92 feet; thence S 81° 38' 02" E 171.83 feet; thence S 49° 28' 42" E 153.91 feet; thence S 35° 58' 50" E 464.66 feet; thence S 0° 39' 03" E 264.02 feet; thence N 73° 30' 17" W 401.52 feet; thence N 88° 30' 42" W 231.08 feet; thence N 10° 02' 13" W 114.57 feet; thence S 66° 36' 23" W 140.00 feet; thence N 23° 23' 37" W 60.00 feet; thence N 5° 00' 56" W 111.44 feet to the POINT OF BEGINNING, said lands lying in the SE 1/4 of NE 1/4 and in the NE 1/4 of SE 1/4, Section 27, containing 9.69 acres, more or less.

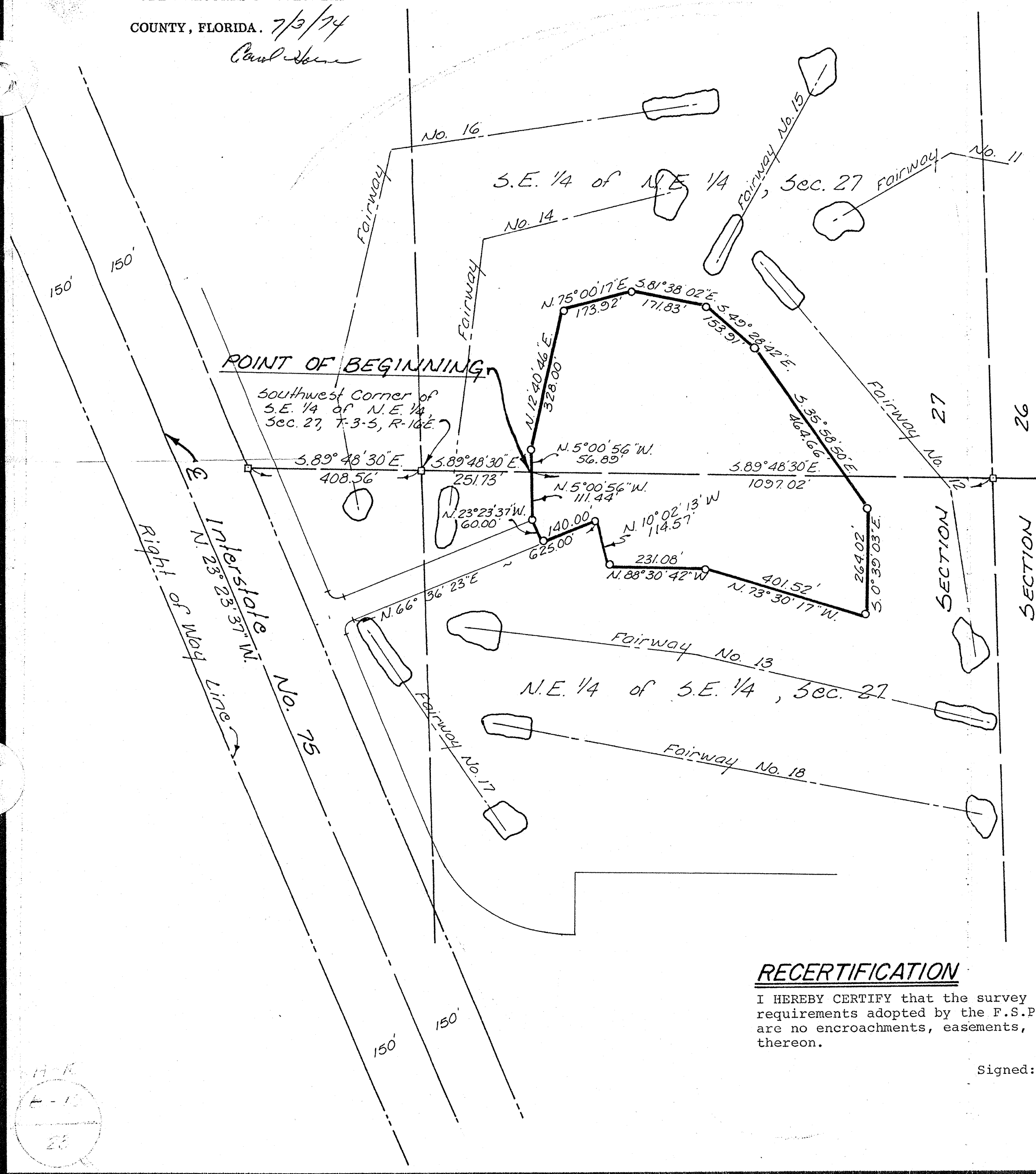
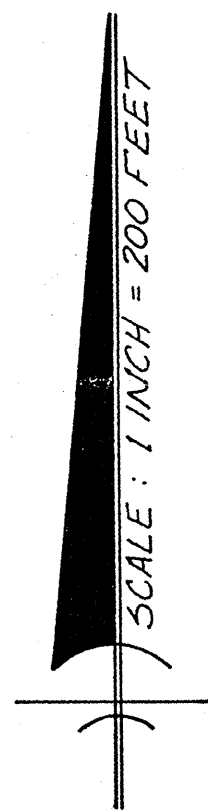
