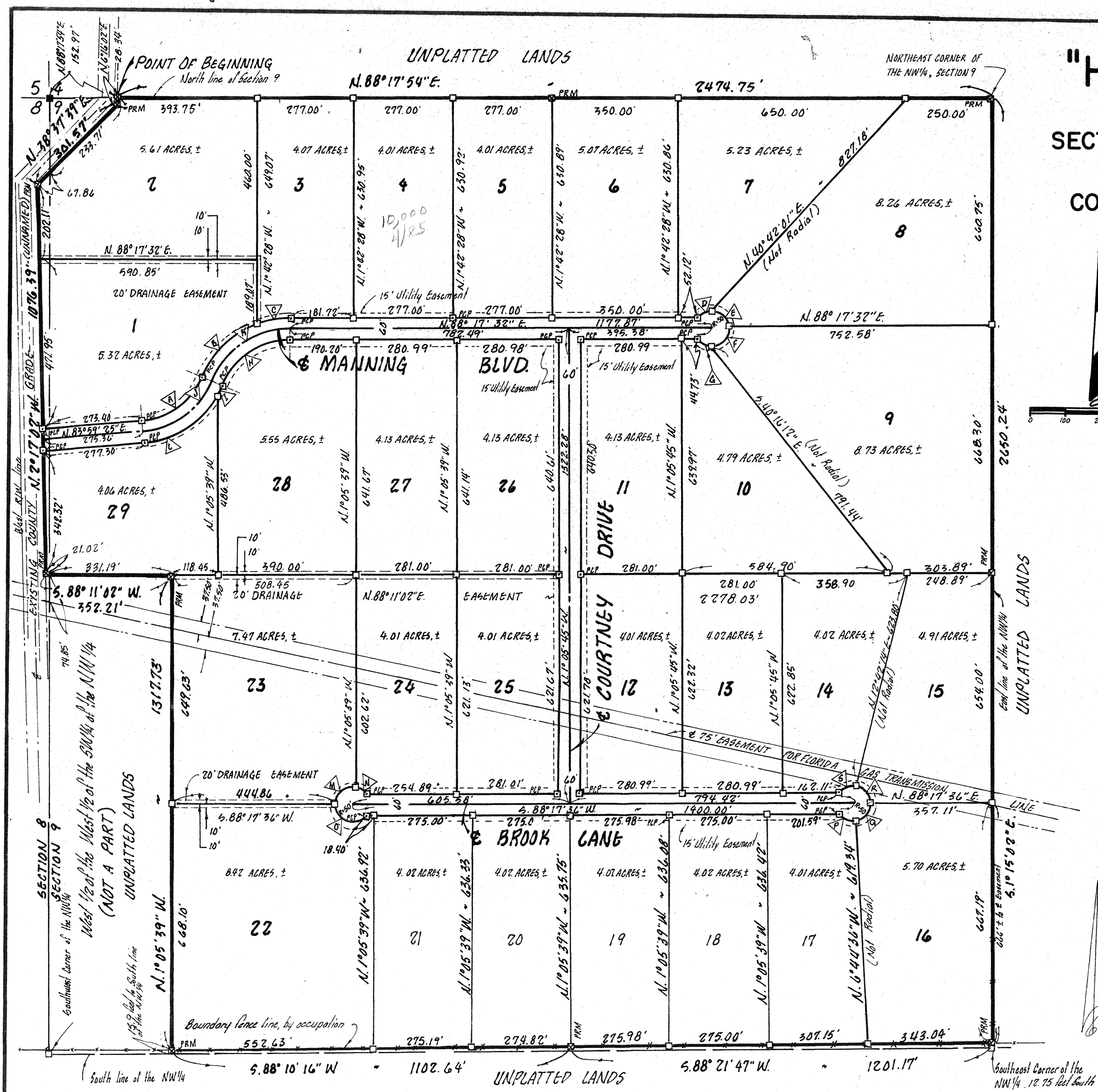

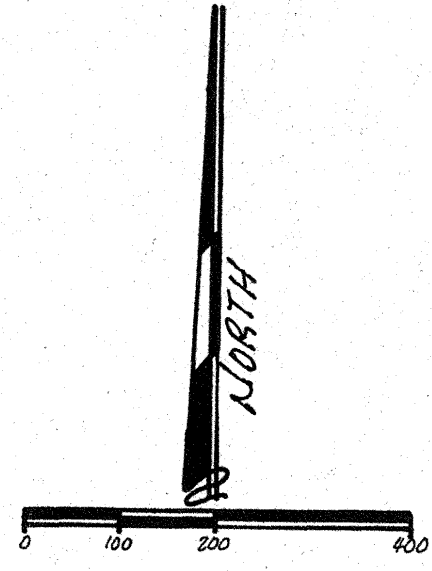

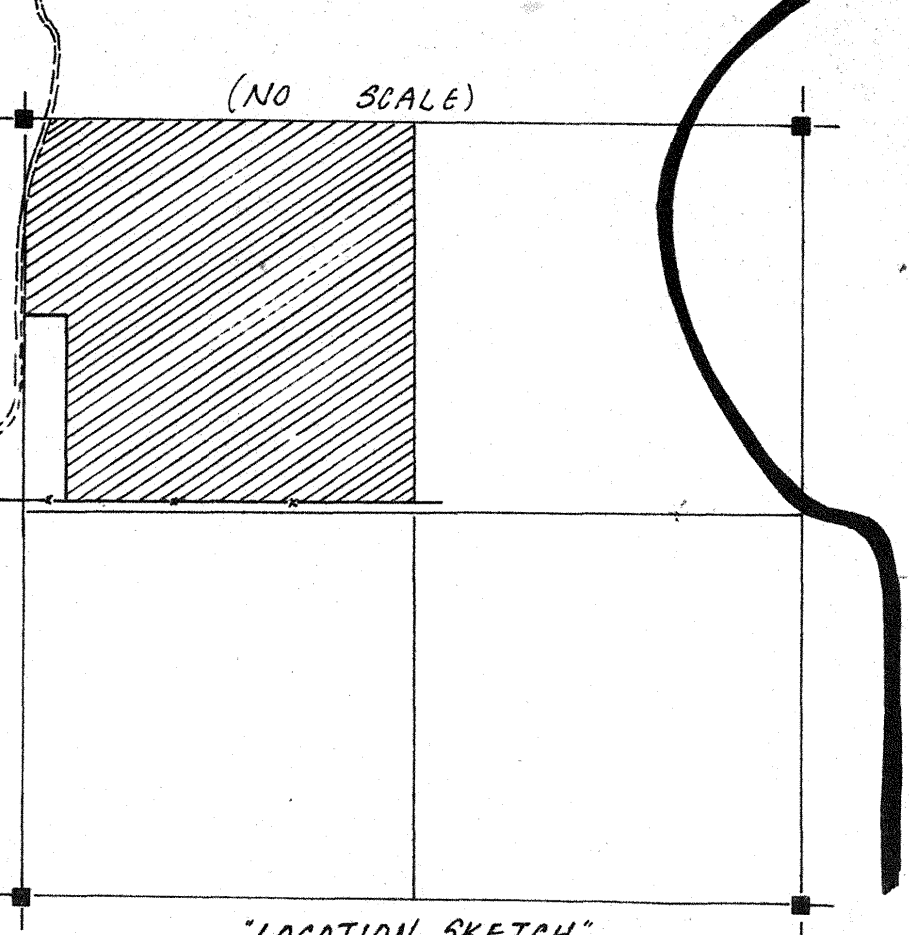

A parcel of land lying in the Northeast 1/4 of Section 9, Township 6 South, Range 17 East, and the Northwest 1/4 of Section 9, Township 6 South, Range 17 East, Columbia County, Florida, more particularly described as follows:
