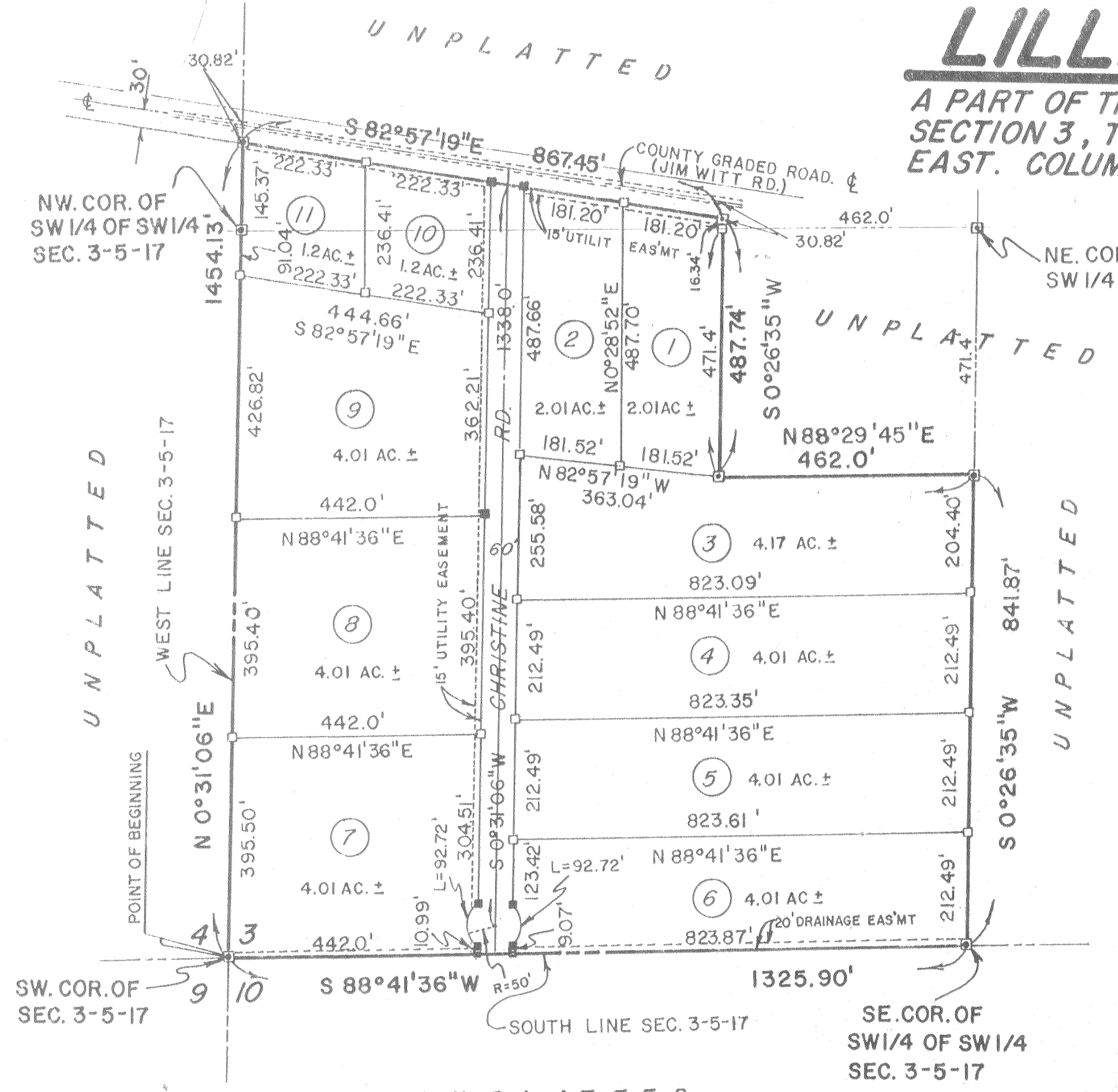

The SW1/4 of the SW1/4 except 5 acres in the NE corner, also the NW1/4 of the SW1/4 south of County Grade (Jim Witt Road), all in Section 3, Township 5 South, Range 17 East, more particularly described as follows: Begin at the Southwest Corner of said Section 3, and run N 0°31'06\"E along the west line thereof, 1454.13 feet to the south Right-of-Way of a County Graded Road (Jim Witt Road); Thence S 82°57'19\"E along said south Right-of-Way, 867.45 feet; thence S 0°26'35\"W, 487.74 feet; thence N 88°29'45\"E, 462.0 feet; thence S 88°41'36\"W along the South line of said Section 3, 1325.90 feet to the Point of Beginning. Columbia County, Florida. Containing 36.39 acres more or less.

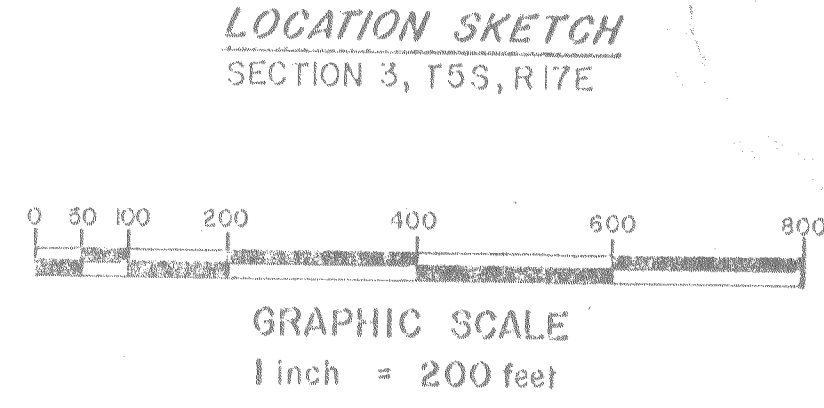
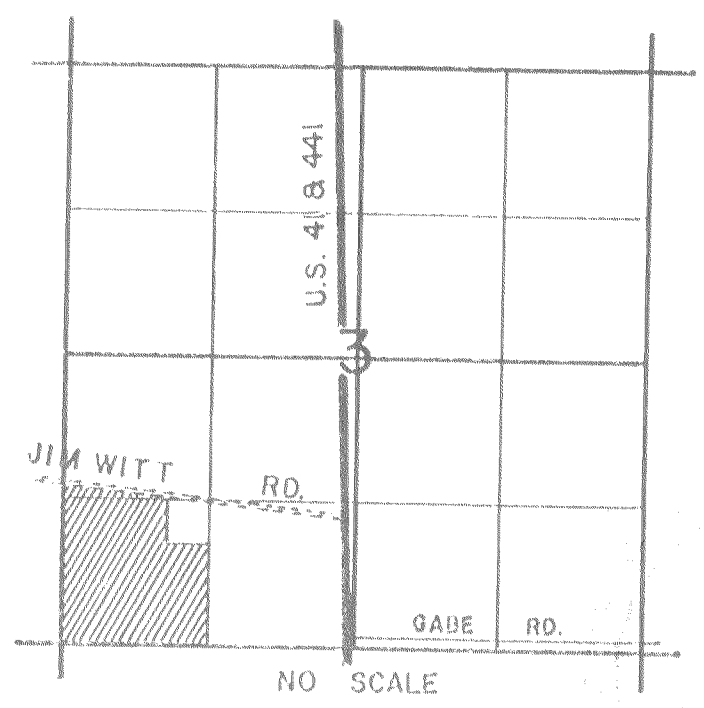
