DESCRIPTION:

COMMENCE AT THE SOUTHEAST CORNER OF BLOCK C, HIGHLANDS ESTATES, A SUBDIVISION AS RECORDED IN PLAT BOOK 2, PAGE 114, PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA, THENCE RUN S08°24'W ALONG THE WEST LINE OF JAMES AVENUE, 282', TO THE NORTH LINE OF PUTNAM STREET FOR A POINT OF BEGINNING; THENCE RUN N81°36'30"W ALONG SAID NORTH LINE, 270.0', THENCE RUN S08°24'W, PARALLEL TO SAID WEST LINE OF JAMES AVENUE, 169.5', THENCE RUN S01°54'E, 111.8', THENCE RUN S08°24'W, PARALLEL TO SAID JAMES AVENUE, 202.88', TO THE SOUTHLINE OF LANVALE STREET, THENCE RUN N88°14'E ALONG SAID SOUTH LINE, 253.99', TO THE SAID WEST LINE OF JAMES AVENUE, THENCE RUN N08°24'E ALONG SAID WEST LINE, 437.56' TO THE POINT OF BEGINNING. SAID LANDS BEING A PART OF BLOCK C OF SAID HIGHLANDS ESTATES AND OTHER LANDS.
