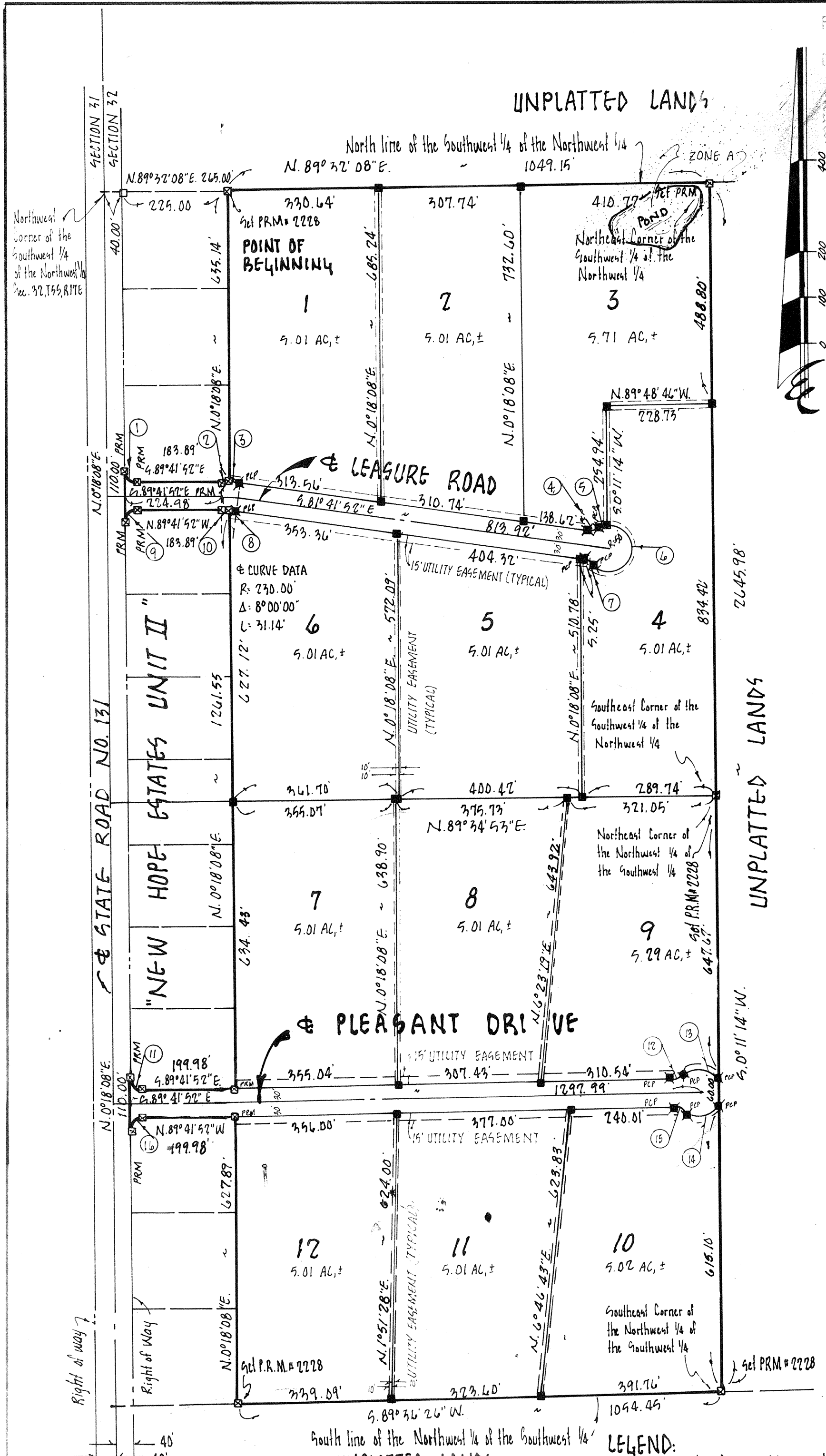
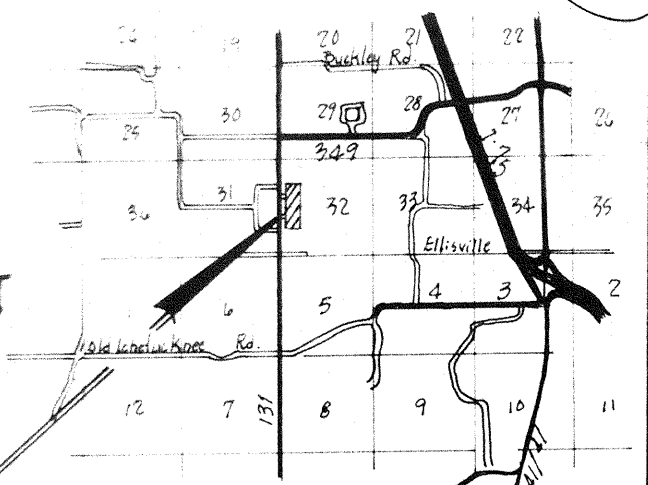


PLEASANT ACRES

DESCRIPTION

COMMENCE at the Northwest Corner of the Southwest 1/4 of the Northwest 1/4 of Section 32, Township 5 South, Range 17 East, Columbia County, Florida and thence N. 89° 32' 08" E., along the North line of the Southwest 1/4 of said Northwest 1/4, a distance of 265.00 feet to the POINT OF BEGINNING; thence continue N. 89° 32' 08" E., along said North line 1049.15 feet to the Northeast Corner of the Southwest 1/4 of said Northwest 1/4; thence 9° 01' 14" W., along the East line of the Southwest 1/4 of said Northwest 1/4, a distance of 1323.22 feet to the Southeast Corner of the Southwest 1/4 of said Northwest 1/4 and the Northeast Corner of the Northwest 1/4 of said Section 32; thence continue 9° 01' 14" W., along the East line of the Northwest 1/4 of said Southwest 1/4, a distance of 1322.76 feet to the Southeast Corner of the Northwest 1/4 of said Southwest 1/4; thence 68° 36' 26" W., along the South line of the Northwest 1/4 of said Southwest 1/4, a distance of 1054.45 feet; thence N. 0° 18' 08" E., 277.89 feet; thence N. 89° 41' 52" W., 199.98 feet to the point of curvature of a curve to the left having a radius of 25.00 feet and a central angle of 90° 00' 00"; thence Westerly and Southerly along the arc of said curve 39.27 feet to the Easterly right of way line of State Road No. 131; thence N. 0° 18' 08" E., along said Easterly right of way line 110.00 feet to the point of curvature of a curve to the left having a radius of 25.00 feet and a central angle of 90° 00' 00"; thence Southerly and Easterly along the arc of said curve 39.27 feet; thence 68° 36' 26" W., 199.98 feet; thence N. 0° 18' 08" E., 126.55 feet to the point of curvature of a curve to the left having a radius of 200.00 feet and a central angle of 4° 36' 40"; thence Westerly along the arc of said curve, 16.10 feet; thence N. 89° 41' 52" W., 183.89 feet to the point of curvature of a curve to the left having a radius of 25.00 feet and a central angle of 90° 00' 00"; thence Westerly and Southerly along the arc of said curve 39.27 feet to the Easterly right of way line of State Road No. 131; thence N. 0° 18' 08" E., along said Easterly right of way line 110.00 feet to the point of curvature of a curve to the left having a radius of 25.00 feet and a central angle of 90° 00' 00"; thence Southerly and Easterly along the arc of said curve 39.27 feet; thence 68° 36' 26" W., 183.89 feet to the point of curvature of a curve to the right having a radius of 25.00 feet and a central angle of 3° 32' 47"; thence Easterly along the arc of said curve 66.07 feet; thence N. 0° 18' 08" E., 636.14 feet to the POINT OF BEGINNING. Containing 64.52 acres, more or less.
